






HARDWIRED

Other hardwired phones require digging/cabling for AC Power and communication lines



Digging & Laying cable is typically charged by the foot, so installation costs rise the further the unit is from power & communication lines and limits location placement due to unreliability.





WIRELESS

CASE Emergency Systems Blue Light Towers receive power from the sun and communicate with cellular technology, so they don't require additional costly infrastructure.



Wireless towers can be installed in even the most remote areas without limitations.



DART



- **2 HOUR INSTALL**
- **BEST IN SOFT GROUND**

The DART is a foundation screw designed by CASE for rapid installation.

A Bobcat drives the DART deep into the Earth, creating a solid base to keep the tower upright. A molded base and gravel are added on top for aesthetics.

HILTI BOLT



- **2 HOUR INSTALL**
- **BEST WITH EXISTING CONCRETE FOUNDATION**

The Hilti Bolt foundation uses 4 J-bolt screws as the foundation for the tower. If there is an existing concrete slab in place, 4 holes need to be drilled for the J-bolts to be inserted.

Otherwise the base is secured in place with a rebar cage surrounding the J-bolts and quick setting concrete.



 - CALL BOX NUMBER (ON BLUE SIGN)
 - NATURE OF TROUBLE
 - LICENSE NUMBER(S)


